"Expanding Implant Treatment Options with the use of Narrow Diameter Implants"

Evidence and clinical based lecture highlighting how narrow-diameter implants complement the current implant armamentarium. Narrow diameter-implants, available from 1.8 to 2.8mm diameter, offer a fixed permanent tooth replacement option for patients that otherwise would not be able to have implants placed and restored. Their ease of use and atraumatic placement makes their use a must for the dental implant practice. Developed more than 20 years ago and, initially recommended to support temporary removable prostheses during the healing phase for advanced bone-grafting procedures and/or conventional implant placement. Their use has since expanded into immediate conversion of full dentures to implant-supported dentures, support for partially edentulous cases and for anchorage of single tooth implant restorations in compromised inter-tooth spaces.
